The Great War - Tracing Your WWI Ancestors By Kate Penney Howard – <u>katepenneyhoward.com</u>

August 1914 marked the beginning of World War I. As genealogists, we often encounter ancestors whose lives were dramatically altered by this "war to end all wars" – not just those who served, but those on the home front as well. On August 4, 1914, Britain declared war on Germany, automatically bringing Canada into the conflict. The United States would follow in April 1917, but August 1914 began the massive mobilization that would affect many people around the world.

WWI records offer unprecedented documentation. The Canadian Expeditionary Force enrolled over 600,000 men, creating detailed attestation papers, medical records, and service files now available through Library and Archives Canada. US researchers can access draft registration cards from 1917-1918, covering nearly 24 million men aged 18-45. WWI Research Tips:

- Start with draft registration cards on FamilySearch or Ancestry
- Check for military service records through national archives
- Look for local newspaper coverage of departures and returns
- Examine pension records for post-war documentation
- Don't overlook women's roles in faith communities and organizations like the Red Cross

Soldiers' correspondence often reveals family relationships, while casualty lists provide precise dates and locations. Hospital records sometimes include next-of-kin information not found elsewhere.

And in a broader context, families left behind often moved for wartime employment, creating migration patterns that continued post-war. Victory gardens, rationing, and war bond drives created community records that mention civilian ancestors.

What about your WWI ancestor, did he see action in August? Almost certainly. The Battle of Amiens (August 8-12, 1918) involved substantial Canadian forces, while American troops participated in preparations for the Meuse-Argonne offensive.

Action Items for Researchers:

- 1. Create a WWI research checklist for your family lines
- 2. Map your ancestors' locations in 1914-1918
- 3. Search local historical societies for war-related records

Victory Over Japan Day - Researching Your WWII Pacific Theater Ancestors By Kate Penney Howard - katepenneyhoward.com

World War II ended on August 15, 1945. We now call this day "Victory over Japan Day." This day began the journey of millions of servicemen and servicewomen home to start the families many of us descend from.

Unlike the European Theater, where forces generally worked in divisions within one branch, in the Pacific Theater, military branches began working together. The Army and Navy (and their Air Forces) and the Marines and Coast Guard all played crucial roles, creating diverse record types scattered across different repositories.

We should also remember that hundreds of thousands of American and Canadian troops were positioned for "Operation Downfall" – the planned invasion of Japan. These preparations created extensive records, even though the invasion never occurred.

Key Record Types for Pacific Theater Research:

- Unit histories and war diaries
- Medical records from Pacific hospitals
- Prisoner of war documentation
- Occupation duty records (1945-1952)
- Transport ship passenger lists

The Pacific Theater's geography created unique documentation. Island-hopping campaigns meant servicemen often served in multiple locations, each generating separate records. Military postal service records can help track movements between islands.

The Pacific Theater affected the Home Front too. West Coast defense installations, aircraft manufacturing, and shipbuilding created a need for workers. People from all over the country relocated to work in defense plants, particularly in California, Washington, and British Columbia.

Some servicemen married overseas, creating international family connections. Others spent extended periods in military hospitals, creating detailed medical records that might mention family health history.

Research Strategy:

- 1. Identify your ancestor's specific unit and theater movements
- 2. Research ship manifests for Pacific crossings
- 3. Check veteran administration records for post-war benefits
- 4. Look for local newspaper coverage of homecomings
- 5. Consider interviewing surviving family members about stories

August 1945 also began the massive demobilization effort. Discharge papers, final pay records, and veteran benefit applications provide detailed personal information often missing from wartime records.

Special Considerations:

Did you know that in 2022, Reclaim the Records won their FOIA lawsuit against the VA? This means that, even if your ancestor's original personnel file was burned during the 1973 NARA fire, the VA may have records for you. These could include birth, marriage, and death records, medical and pension documents, employment details, home purchase information, education transcripts, and military details. The GI Bill enabled college education and home ownership,

Since Covid-19 and the difficulty of getting permission to enter private land, the search for abandoned cemeteries has basically ended. We are presently concentrating documenting African-American Church Cemeteries. With the assistance of Sanita S. Cousar we documented New Hope Baptist and Upper Hope Station Baptist Church Cemeteries. She has also arranged for us to enter and document additional cemeteries. Now with the cooling temperatures we hope to soon start documenting church cemeteries. As seen in this picture, it was possible to get in a nap.

Cemetery Research: Making the Most of Genealogy's Golden Season By Kate Penney Howard - katepenneyhoward.com

Autumn transforms cemeteries into genealogical goldmines, and October offers perfect weather for cemetery research. Falling leaves reveal previously hidden stones, while cooler temperatures make extended research sessions comfortable. Successful cemetery research requires strategy beyond simply photographing headstones. Walk systematic patterns to ensure complete coverage—many significant stones hide behind larger monuments or sit in cemetery corners. Look for family groupings, as related families often purchased adjacent plots across generations.

October's unique advantages include better stone visibility as vegetation dies back, comfortable working conditions for extended visits, and reduced cemetery maintenance activity that might obscure stones. Many cemeteries also complete their annual record updates in autumn, making office records most current.

Essential Equipment:

- Portable mirror to reflect light onto worn inscriptions
- Soft-bristled toothbrush and water for gentle cleaning
- GPS device or smartphone app to record exact locations
- Notebook for recording nearby graves and family groupings

Research Strategies:

- Visit the same cemetery in different seasons, as winter reveals stones hidden by summer growth
- Check cemetery office records for burial registers, plot maps, and maintenance logs
- Interview groundskeepers who often know family stories and unmarked grave locations
- Photograph the entire stone, including base and back, where additional information often appears

Digital Resources:

- FindAGrave.com for online memorial and photo sharing
- BillionGraves mobile app for GPS-linked cemetery mapping

Local genealogical societies often maintain cemetery transcription projects

Remember that cemetery research extends beyond individual graves. Family plots tell stories of love, prosperity, tragedy, sorrow, and community connections that illuminate your ancestors' entire social world.


Q: Joe Ravenell: It looks like the Gaillard family-owned Springvale Plantation. The Gaillard family and Connor family also owned the Rocks and Belmont plantations in Berkeley/Orangeburg, SC. What records are available regarding enslaved people on the Springvale Plantation? My family oral history says, my great grandfather was put on a train as he waved goodbye to his mother and sister. His name was Charles, Charles Ravenel. It looks like there was a train line back in the day that one could end up in Eutawville, SC. On her journey, Abigail Pierce Ravenel married a Ravenel and listed a number of enslaved people on her probate papers.

A: Do you know or have this information:

Q: Sandra Parham Turner: You may have read the article I contributed to the latest CFM Family Association newsletter, which tells my family connections, but I am a descendant of Henry JR Coleman and Mary Mobley Coleman through their granddaughter, Mary Emily Coleman, whose stepfather was David Roe Feaster. I contacted the Fairfield County Historical Museum looking for information about the diaries of David Roe Feaster, and they gave me your contact information. I have a PDF copy of one from 1884-1889 that was typed up, I'm assuming several decades ago. I'm trying to find where the original might be and wondered if it was housed at the museum. In the article, I wrote about DRF's granddaughter, Edith Feaster May, who had saved a lot of history, and her daughter Sybil gave it to me. Sybil died last year, and now I have no one to explain to me where the information came from. For instance, either Edith or Sybil transcribed by hand another diary that DRF kept from 1905-1909, which I have transcribed on my computer. Then I found where one of them had written down a few entries from the 1884-89 diary that I assumed were in the typewritten copy, but they were not. So now I think that the typewritten copy may not be a complete transcription. I have no idea where they were when they copied either of these diaries or who might have had the originals when they did. Would you have any information I could go on to track down the 1884-89 diary? It may be lost to the ages, but if there's a possibility it exists somewhere, I would like to find out.

I thank you for any help you can give me!

A: The Fairfield County Genealogy Library does have a PDF copy of this diary, but not the original. Ron Chicone a Coleman-Feaster-Mobley trustee, checked at the Carolinian Library, and they do not have the original. Pelham Lyles the Fairfield County Museum Director said she only has a digital typed copy and does not know where the original is either. The Historian for Coleman-Feaster-Mobley Family Association is very ill, and we have been asked to give them some time to recoup. Please check back later.

Died 28 April 1828 in Greenwood County, South Carolina

Records I am seeking:

Burial records or cemetery listings for Elizabeth

Probate, estate, or will records

Land grants or deeds tied to Samuel Cross

Church records (Presbyterian or Methodist, likely) that may mention baptisms, memberships, or burials Any family groupings (e.g., census substitutes, tax lists, or Bible records)

Q: Ron Chicone Jr.: I wonder if you could help me. I'm trying to date this petition for a ferry at Shelton, SC. It mentions Ainsley Hall, John Thomas, and Thomas Shelton as owners of land on either side of the river. It mentions the "State of South Carolina" so it's after the Revolution. It places the ferry "about 1/4 mile above the mouth of Tiger River." Here's the petition: Online Records. Do you have the old plats for that area on your website?

On the plats question, the problem is it is rather late -- 1824 or thereabouts. So the 3 tracks aren't necessarily originally granted in their names. It would require research to look up the deeds or surveys for when they were either granted or sold to the 3 named petitioners. I won't be able to do that for a few weeks at least.

Thomas M'Donald, his heirs and assigns, for the term of Dec. 1624. seven years, who shall be allowed the same rates of ferriage \ is beretofore allowed by law at the said ferry. Sec. 6. I: **Ken Shelton**: The citation is in my book -- it's the Cherokee Expedition list for Col. Richardson, late 1759 - Jan 1760, that had a number of western Fairfield men -- couple Mobleys, Thomas Addison, etc., and John and Ephraim Lyles. My opinion is this is more appropriately called a militia unit because it was a short term unit was raised for a specific purpose / expedition, and disbanded afterwards -- it wasn't a standing military organization of the kind you found in Charleston as a persistent British Army or colony unit.

There were a few Macons -- there was Henry J. Macon and Hartwell Macon, and their children. I don't know how long they lingered on -- they are in deeds up to the mid-1800's at least. It may be that they daughtered out, so people in Fairfield may be related only through a daughter & no male lines extend down to the present. The sons may have all died out or moved elsewhere. I know both Henry and Hartwell (Heartwell) had land in the Little River area where the eastern Beaver Creek branches almost intersect, and somewhat down-county to the southwest of the Little River near the Broad River. You are probably talking about the latter lands. You sent me a copy of a deed I had you look up for Henry -- he sold his Broad River area land on it -- I had hoped it was the sale of his Little River land, but it wasn't.

I do recall seeing the state petition entry for I think it was William Lyles -- I'll have to go back & look. Note that it would be the "Strother Ferry" meaning the town / village of Strother ferry vice "Strother's Ferry". Strother's Ferry is the same thing as Shearer's Ferry (briefly called Brierley's Ferry by the British during 1780-1782, and could have been called "Minor Winn's Ferry" for another short period in the 1785-1788ish timeframe when Minor Winn owned it -- although he called himself "of Shirer's Ferry" when he petitioned for ownership of it and executed a deed). Richard Strother bought the rights to it from Minor Winn, who seems to have gotten it via post-Revolutionary War seizure since Gasper Brierley was a Tory and the Shearer's seem to have been also -- Martin Shearer was dead, but I think Isaiah Shearer was on a Tory list. Richard Strother went back and bought out the ferry land from Isaiah Shearer, Martin & Elizabeth Shearer's son, so he made his claim for the ferry rights (in my opinion) much more solid than Minor Winn's. Richard Strother operated it during his lifetime, and after he died, it passed to his daughter (I think her name was Nancy Rochelle Strother) & it was operated in her behalf by William McMorris (her guardian). The legislative records indicate it was discontinued around 1810-ish as it is named (as required) as a neighboring ferry in other ferry petitions to establish rates, but then dropped in the 1810's and other ferries established in the immediate area -- which would have been disallowed if it was still in operation because each one was given a 3-mile or so exclusion zone on either side as part of the legistative certification (it varied a little as I recall -- I seem to remember a zone up to 7 miles each way in one or more cases).

So "Strother's Ferry" discontinued around 1810ish, and then William Lyles would have started up a ferry in the area of the town of Strother, which might well have been called "Strother Ferry", but being a different ferry and likely different physical location than "Strother's Ferry" -- I'll dig out my petition files & see if I have the copies (which I'm pretty sure I do since I copied all the Broad River entries up to the 1820's). That's another topic I'd like to eventually write an article on -- a survey of the various Broad River ferry points from Sandy River down to Winn's Bridge near the Little River confluence, with years of operation, owners, access roads, and hopefully a plat location.

The ferry points dictated the flow of people, goods and commerce for the entire western half of the county. If you get any volunteers, I can provide the exact record series number & etc. for the SC Dept of Archives & History -- I have the archives accession sheet. There are 5 volumes of quit rent rolls -- looks like the first 2 volumes cover 1733-1742, so those are not needed unless you want to look for Charleston-area folks -- I doubt there will be anything of significance for the entire Fairfield area that early. The last 3 cover 1760-1774, so it would require a page-by-page look for these (and I would appreciate a look for a select list of other surnames while you are at it!) to find the entries for





the Liles / Lyles family. I've never seen the actual volumes, but I would guess about 30 minutes per volume -- figure they are about the size of a deed book, which would take about 30 min to flip through looking just for surnames. Add in an indeterminate time for copying -- I would imagine that since they are originals, you will have to pick the pages to get copied and have the staff do them. Add in time to request the volumes and have them pulled from storage, and you are probably talking about half a day -- say 2 ½ hours of actual work time and 1 1/2 hours of waiting for retrieval and copying. So, plan ahead to do some other research during the wait time.....



HENDERSON'S ISLAND

file Lyles

Located in the Broad River between the mouths of the Tyger and Enoree Rivers, Henderson's Island was originally granted by the King to John Marlowe in 1757. Later in the possession of Daniel Mazycke the island was known as Mazycke's Island. Purchased by 1800 by John Henderson of Newberry District the island has ever since been called Henderson's Island. This circa 1800 plat identifies surrounding plantations. John Henderson's second wife was Elizabeth Liles (daughter of James and Lucy Liles Liles and grand-daughter of both Ephrain and Williamson Liles). Their only son, James Madison Henderson and his wife Sallie Anderson Glenn (daughter of James Blanton and Elizabeth B. Liles Glenn, grand-daughter of Ephrain and Elizabeth Frances Foote Liles, and great-granddaughter of Arromanos and Rabecca Valentina Liles), lived on the Island for many years prior to the Civil War.

Among the plantation site's included on the plat is that of Reuben Sims. Two of Reuben and Nancy Saunders Sims daughters, Mary and Drucilla, married sons of Arromanos and Rebecca Valentine Liles, John and Valentine Liles, respectively. Another daughter, Cecilia Sims married James Liles (son of Little Ephrain Liles and his first wife and . grandson of Williamson Liles and his first wife).







I: Pelham, Thank you so much for sharing this information. I don't think the book from Camden and the Thomas W. Lauderdale Collection are related. My brother and I would guess that the Mary Lauderdale book got to Camden through the survivors in the Lemmon family who cared for Mary's husband, Thomas, after her death. Thomas was an uncle to Thomas W. Lauderdale.

It is my understanding that there are Black Lauderdale's in Fairfield County today, and, if so, they may be interested in seeing the Mary Lauderdale book.

My brother, George S. Lauderdale Jr., has done a lot of research on the family, including the extended family of Thomas and Mary McMullen Lauderdale, and he may be able to lend some more hints in coming days. He said her parents were born in Scotland, she was born in America, and Thomas came into land holdings and planting when they married. I am attaching a couple of files of relevant information.

Much of it comes from Pauline Lauderdale's 1991 book, "The Lauderdale's of Fairfield County, South Carolina, Their Descendants and Allied Families." I know you already have that information. I have seen a copy of this book in the Fairfield County District Library in Winnsboro.

I hope these two PDF files work:

"Lauderdale Collection": Containing the two-page inventory of books in the Thomas W. Lauderdale Collection, which was loaned to the Governor's Mansion in 1965 (the list came from the Governor's Mansion staff); four pages of correspondence regarding that move that I believe I obtained from the Governor's Mansion staff; and three pages from Pauline's book regarding the Lauderdale Collection and other bequests of Thomas W. Lauderdale to the library. It includes minutes of a Fairfield County library board meeting when the loan was approved.

"Thomas Lauderdale": Containing three pages, all from Pauline's book, with a sketch of Thomas Lauderdale's life that was originally written by my grandfather, the Rev. David Thomas Lauderdale Sr.; a copy of Thomas Lauderdale's obituary; and a copy of his will. HIs books were bequeathed to his brother, Dr. David Lauderdale (my g-g-grandfather), but Dr. David preceded Thomas in death.

The Lauderdale Collection at the Governor's Mansion never included any personal books. It appears to be a handsome collection of nicely-bound classic books that were perhaps a status symbol in Thomas W.'s day. Not all of them were on the shelves in the Mansion's beautiful library when I visited. The books in the collection that I saw on the shelves were signed by Thomas W. Lauderdale. Most did not appear to have been opened, much less read. But in one book there was a page of stationery from a New York investment house that would be a clear sign of use by Thomas W. Lauderdale. (A highlight of scanning the Mansion's library shelves was pulling a book that was signed by Eliza Lucas Pinckney.) The Thomas W. Lauderdale Collection got to the Mansion in 1965 at the request of new first lady Josephine McNair, wife of Gov. Bob McNair, as she wanted to upgrade the condition of the Governor's Mansion. The loan was facilitated through Miss Estellene P. Walker, then director of the state Library Board. Miss Estellene knew of the Lauderdale Collection and saw it as an appropriate response to Mrs. McNair's call for help in stocking a new library at the Mansion. I hope this helps.

You asked which Lauderdale tree is my family.

I descend from Dr. David Lauderdale, one of four children to arrive with their parents in Charleston from northern Ireland on Nov. 1, 1817. His parents, William and Jane Milling Lauderdale immigrated to help her kinsman Capt. Hugh Milling with his land holdings in Fairfield County. (Thomas was another of those children, along with William, who moved to Texas, and Mary Ann, who married James Lemmon.)

My lineage goes from Dr. David and Jane Russell Lauderdale (she was the widow of store owner Montgomery Lemmon); to George Russell Lauderdale ("the first," Pauline would call him) and Sarah (Sallie) Coleman Lauderdale, who operated the Lauderdale store; to the Rev. David Thomas Lauderdale Sr. and Sallie Chapman Lauderdale of Rockbridge County, Virginia, where David, who was reared in Winnsboro, was a pastor for more than 50 years and where he is buried; to my

parents, the Rev. George Seebert Lauderdale Sr. and Sally Burke Lauderdale of Georgia. (Mama is the last of that generation still living. She is 96 and bedridden in a nursing home in Georgia.)

So I come down the Dr. David and Jane Russell line, and specifically down the line of the Rev. D.T. Lauderdale. He had six children in my father's generation, and there are/were 17 in my generation.

I have a daughter here on Hilton Head Island and a son living in Dripping Springs, Texas. We have one grandchild, Bram Mathis Lauderdale, who is almost 7. From Dr. David's line, Bram is only one who could carry on the Lauderdale name.

Recent news from our wing includes the announcement that my first cousin, James Russell (Jim) Lauderdale, will be inducted on Oct. 6 into the Nashville Song Writers Hall of Fame along with Emmylou Harris and Brad Paisley. He is the son of the Rev. Chapman and Barbara Lauderdale. He has previously earned two Grammys and the Lifetime Achievement Award from the Americana Music Association. Also, Carter Higgins, the daughter of a first cousin and a great-granddaughter of the Rev. D.T. Lauderdale, was named in July as a finalist for a Virginia Literary Award from the Virginia Library for her children's literature. And I received the E.A. Ramsaur Award in 2024 for the second consecutive year from the S.C. Press Association for Best Editorial Writer in the state.

111. Thomas Lauderdale was born Jan. 20, 1793. Died 1881, aged 28 years. The Fairfield Mews and Herald of that date says: "Time has passed away one of the most prominent landmarks of Fairfield. Mr. Lauderdale was successful in business, and become one of the staunch citizens of our county". For more than 70 years he was a consistent mamber of the Freebyterian church. For some 50 years up till his death he was a ruling elder in Selem Freebyterian Church. He married Miss Mary McMullen, who like himself was of Scotch descent. He was a farmer and ewned a large farm and dwelling on Possum Branch where they lived. They had no children. His wife died June 50, 1856, age 76 years. He then made his home the rest of his life with his nephew by marriage, Dr. W. K. Turner who married Miss Elizabeth Lemmon. He was eminently picus, a life member of the American Bible Society, and an earnest student of the Bible. At the time of his death he had nearly concluded reading the Bible through 115 times, besides having read through Scott's Commentary on the Bible which is in 5 large volumes, nearly 115 times. He owned and read many other books, chiefly of a religious nature such as "Calvin's Institutes", and "Dambignes History of the Protestant Reformation." He and his wife are buried in old Jackson's Creek cometary.)

He was a close friend of the scliblarly minister Rev. James Boyce, D.D., then pastor of New Hope A.R.P. Church, and later professor in Effeking Theological Seminary, editor of "The Christian Magazine of the South," and associate editor of "The A. R. Presbyterian".

Henry Johnson, colored, whose people were owned by the Lemmons before the Civil War, said that when "Uncle Tommy", as he was fondly called by relatives and friends alike, would visit the Lemmons; he would often go off alone into the woods and spend many hours in prayer and reading God's Word.

David R. Coleman, who served as elder in old Salem Church with, "Uncle Tommy" said that Uncle Tommy was always in his place in the Lord's house on the Sabbath day; that he always sat in the same place, the "Amen Corner", and would rest his bald head against the wall; and that years after Uncle Tommy died, you could go to the old Church and see on the wall the mark that he left.

Back in those days elders in the church took their duties seriously. The old mimites of the Salem session show that Uncle Tormy was faithful as an elder in attending; and that many of these meetings were taken up in trying and disciplining church members for conduct considered by the session as unbecoming.

billiam J. Lemmon, grandnephew of Uncle Tommy, says that it seemed to him, he was a boy then, that Uncle Tommy's public prayers at Church and his prayers in the home around the family alter were over 20 minutes long.

Uncle Tommy, as did the other Church elders in those days, visited the homes of the church members and there Yead prayer with the families, and catechised the children in the Shorter Catechism, Mussell Milling, a relative of Uncle Tommy's and who when not over 15 years old ran off from school, joined the Confederate army and had his legs shot off in

Often he was at the home of John Hontgomery Lemmon, when Uncle Tommy would come, and would call all the children in to question them in the catechism, Uncle Tommy was then old and deef. He would ask a question; and, all unseen by him, "Russ" would have the catechism open at his side. "Mait, Uncle Tommy", he would say, "let me think," All the time he was turning the pages to the right answer, and would then read off perfectly answer after answer. Uncle Tommy was greatly pleased with Cousin Russ; proficiency in the catechism and would say "That's wonderful, Russ; wonderful!"

To one of his relatives he said by had come out so as to be near the graveyard, and the day before he was taken sick he arranged his earthly affairs. On the Wednesday before his decease, he complained of feeling unwell, but railled and sat up ustil Sunday. Then he time to his bed and passed most of his time in a state of semi-unconsciousness. On Wednesday he ravived for a few minutes, and then passed off guietly without saying a world

On Thursday he was buried at Jackson's Creek (Lebanou) Church. The services were performed by the Rev. Mr. Millen. Though passing away at this ripo old age, Mr. Landerdalp will be imposed. He was the embodiment of freeprosubable integrity and true Christian faith. Pence to his ashes.

The Last Will and Testament of Thomas Lauderdale deceased

State of South Carolina County of Fairfield

I Thomas Lauderdale of the County and State aforesaid being of sound and disposing mind do make and ordain this as my laast Will and Testament hereby revoking all other Wills and Testaments heretofore made.

- Item 1 My soul I will to God who gave it.
 " 2 After my death I will that my body be plainly and decently buried.
 - I direct that my executors hereinafter named pay out of
 - my personal estate all my debts if any there be. I give to my brother David Lauderdale my bookcase secretary and books.
 - I give to my nephew Thomas, son of David Lauderdale my gold watch.

More windows into the past. Thank you, David, for such a complete description of the loaned collection and the Thomas Lauderdale history. I think you know that the museum has on display the framed oil painting by Prohaska (I think that is the correct spelling but will check it tomorrow) of the sea weed gatherers. The figures in the scene are wearing wooden clogs and there is a windmill on the horizon, so the painting appears to represent a Dutch scene. I guess blocky wooden shoes were appropriate for people who live in such a wet climate!!

I will follow up the Lemmon descendants who would have been in Camden. And yes, I will check out the African American descendants of the Lauderdale family. I have noted their early 20th Century graves in the town's cemetery and I remember an old Mr. Lauderdale who lived across the branch where Moultrie and Washington Streets merge at a fork. He had a hillside pasture where his house sat on a slope, and he had a mule which always seems to have had a dragging chain that must have tied him to the barn. Said mule would break free during the night and come visiting our backyard horses a few blocks closer to downtown Winnsboro on the corner of Moultrie and Fraser Streets. Honky, honky, he would loudly call out as he clippety trotted up the pavement dragging his chain to visit our horses. My father would have my sister and me to escort the old fellow back down the hill to Mr. L's., farmstead. Maybe there are some black Lauderdale descendants who would be appreciative of a viewing and some help tracking their family history. Too bad slaves only had given names during that time. However, we have the ancient Boyd family bible in our collection that lists the slaves of that Jackson Creek area family. In past years, I have corresponded with a family researcher whose family contained many of the given names of the listed slaves. She has been able to connect up with those names and it has been a rewarding friendship we have developed over the years. Her family moved west and she has published a narrative of these family members and their origins in Fairfield County. I would love to chat with you and/or your brother about the gathered family information. My number is 803-727-5908. I have memory of the early family name McMullen in the Rocky Creek area of Chester County. The Covenanter families who immigrated in the seven ships of Rev. William Martin settled there and intermarried among our Ulster/Antrim families across the area. We will be presenting some scenarios about Rev. Martin in an upcoming (April) historic event to be set on the surrounding property of the old Mt. Zion School where Lord General Cornwallis's 2300 troops camped for 4 months during the fall/winter of 1780-81.

Attaching here an article by Gary Ford (who is deceased, I think) about his James Russell ancestor who was the stone mason for the structures in the Jackson Creek community in Fairfield County. He visited the museum many years ago and there is another descendant who lives in Newberry and visits occasionally. -Pelham

Pelham, Thank you for those stories.

I'll call you, but meanwhile I am attaching six files I received last night from my brother, George, most related to the birth listings that he called "chilling."

Attached are copies of Fairfield District slave schedules from 1850 and 1860. In 1850 there were 18 slaves under the Thomas Lauderdale name and in 1860 there were 25. The age and sex of each is listed, but not names.

Also, attached are examples of "Uncle Tom's" handwriting and some real estate transaction records from Fairfield court files.

The last birth entered in the Mary Lauderdale Psalter was in 1868, which is after Mary Lauderdale's death in 1866, and also after the 13th Amendment was ratified in December 1865 making slavery illegal.







More time travel...

For the past 15 years I lived with my now deceased partner Val Green in the site indicated on this map. As both his (Aiken, Crowder) and my Lyles ancestry were based in the area here since 1745 (Lyles) and 1790 (Aiken), I explored and studied the old roads and house sites in the area with him. I traveled the dirt road called Possum Branch often. It crosses back washes of Possum branch in 3 places as it flows to the nearby Little River on the east (outside of this map range). I recently tried to pass through this road on the way back from an event I had attended near Spartanburg (Gaffney) and was dismayed to find the three concrete slab bridges are impassible and barriers placed to prevent "back roaders" like me from enjoying a shady route.

I had often glanced at a piney old field located on the NE side of the road just beyond the fork of Old Harden and Possum Branch where large boulders and the hinted remains of a sunken road or drive led off the road going up to a hilltop, and I always wondered whose old home might have been located there. My friends, the Yonge's have owned much of the land in that area since early times and I think Charlie Yongue might be able to shed some light on my theory. He owns the property there now.

The Lauderdale's must have traveled west on Possum B. (referred in some old texts to as Columbia Rd.) to its joining with Old Harden Rd. in order to meet up with the crossing of Highway #215 or the old Cherokee Rd. to go to church at Salem. Seeing from your family papers that after Mary's death, Thomas went to live with W. K. Turner whose lands were on #34 (Road to Winnsboro), that would have put him a little closer to the Jackson Creek Community where he and Mary are buried in the Old Lebanon cemetery. The W.K. Turner house stood until about 20 years ago, probably a remnant of the 1790s, torn down against my and others' protests by a descendant of the Turner's.

Thanks for instigating my reminiscing here and especially for sending the slave records and deed abstracts. All of this will be reproduced and also digitized for our Lauderdale family papers. Yes, it is so sad that the census records did not name the slaves. I have a ledger from my great great grandfather's hand concerning his son's plantation records that he updated for his daughter-in-law after William Boykin Lyles was killed at the Battle of Seven Pines. It has several pages listing all of the slaves' names, dates of birth, and values. Many present-day African American Lyles's who still live in the area are genetically kin to me (via DNA testing).





MAJOR HEYWARD JOSEPH HINDMAN

Heyward Joseph Hindman was born in Chester, SC. September 2, 1902. He was the son of Hiram Joseph Hindman, born in Chester County, SC February 9, 1870 and Effie Anna Huggins born in Lincoln County, NC April 13, 1879. His paternal grandparents were Martha Ford born in 1844 and Hiram Joseph Hindman born 1821 in Crester County, SC Joseph was called to defend the area during The Civil War.

Hiram Joseph Hindman owned and openated the Chester Dry Goods just down the hill from the Chester Book Store and across the street from the Standard Drug Store.

Heyward grew up on Hemphill Avenue next door to the Bankheads. His education began at Foote Street School. He graduated from Chester High School where he excelled in athletics. He and his family were members of Bethel Methodist Church. During the summer the various churches had basehall teams. He played on the Methodist Church team.

He graduated with honors from Presbyterian College Clinton, SC. He also received

a Lieutenant's commission in R.O.T.C. He received his Master's Degree from Vanderbilt University.

After graduation he was Athletic Director and taught Math and Science at Morris Harvey College in West Virginia. He returned to South Carolina to become the Commandant of Baily Military Academy in Greenwood, SC.

He served as Army Officer Inspector of C.C.C. camps and was stationed at Fort Moultrie, SC and Globe, NC. When World War II began he was transferred to Atlanta, GA. After the attack on Pearl Harbor he was sent to Hawaii. He was lost in the Pacific in April 1942. A marker for him is in Arlington National Cemetery, his wife, Lucille Wilson Hindman, received his Purple Heart Award.



Biographical Sketch of Henry D. Palmer

She often invited them to go to meeting with herself and family, but Mr. Palmer always replied: "I am too busy." One Sunday morning she stopped and first asked Mrs. Palmer to go with them. She replied: "I'll go if Henry will; you ask him." So she went out to his shop [I recall a reference to his being in his younger years a carpenter, AGH, 21 March 2008] and said: "Won't you go to church with me to-day?" He replied: "No, I haven't time." Then she said: "Henry, some time you'll have time to die," and left him. That proved the alarm-bell to him. Shortly he went into his residence and said: "Wife, let's go to church." They went, and kept going.

They together read the Bible and prayed. In due time they wished to unite with the church. As they objected to being sprinkled, the Presbyterian minister immersed them. Just before he was baptized he took his tobacco from his pocket and threw it far away, saying: "I read in the Bible that we must put away all filthiness of the flesh." As he continued to study the Bible, he found that he could not subscribe to the Westminster Confession of faith; so in kindness he withdrew and united with the Baptists.

He came to Illinois first in 1819, and for a time was associated with the "Christian Settlement" that had been formed the year before in Lawrence County, seven miles northwest of Vincennes, Indiana. The locality is now known as Allison Prairie. The settlement was founded and the church there formed by the good people of the Christian Denomination. Mr. Palmer was then formally affiliated with them.

He left there and went to Indiana, but returned to Illinois in 1835 and settled on Crow Creek, in Marshall County. There he bought a farm, on which he made his home to the close of his life. Thereafter, his course was that of the brave and self-sacrificing pioneers. He traveled and preached far and near. He was one of the strongest preachers of the period, and most of the infant churches of central Illinois were helped by his able, Scriptural sermons. He replied: "No, I haven't time." Then she said: "Henry, some time you'll have time to die," and left him. That proved the alarm-bell to him. Shortly he went into his residence and said: "Wife, let's go to church." They went, and kept going.

They together read the Bible and prayed. In due time they wished to unite with the church. As they objected to being sprinkled, the Presbyterian minister immersed them. Just before he was baptized he took his tobacco from his pocket and threw it far away, saying: "I read in the Bible that we must put away all filthiness of the flesh." As he continued to study the Bible, he found that he could not subscribe to the Westminster Confession of faith; so in kindness he withdrew and united with the Baptists.

He came to Illinois first in 1819, and for a time was associated with the "Christian Settlement" that had been formed the year before in Lawrence County, seven miles northwest of Vincennes, Indiana. The locality is now known as Allison Prairie. The settlement was founded and the church there formed by the good people of the Christian Denomination. Mr. Palmer was then formally affiliated with them.

He left there and went to Indiana, but returned to Illinois in 1835 and settled on Crow Creek, in Marshall County. There he bought a farm, on which he made his home to the close of his life. Thereafter, his course was that of the brave and

self-sacrificing pioneers. He traveled and preached far and near. He was one of the strongest preachers of the period, and most of the infant churches of central Illinois were helped by his able, Scriptural sermons. He was present and helped in the formation of the General Christian Missionary Society at Cincinnati, Ohio, in 1849. In 1850 he was at Shelbyville, and assisted in organizing the State Missionary Society and was chosen its first president. He taught O. A. Burgess the way of the Lord, baptized him and induced him to become a preacher.

In this connection it is proper to mention F. R. Palmer, who had been for some time preaching at Caneridge. He was a warm friend of Mr. Campbell, and often with him during his visits in Kentucky. He had been educated by B. W. Stone, and was a man of superior abilities, a fine preacher and entirely friendly to the union, as was also his brother, Henry D. Palmer; and their history serves still further to illustrate the sufficiency of the Bible as the source of religious light and the basis of Christian union. Called providentially in the midst of an irreligious community in South-west Tennessee to the study of the Scriptures, they soon discovered how different were modern churches from the models given in the New Testament. Both were men of fine personal appearance, strongly resembling Henry Clay, not only in form and features, but also in gifts of oratory. Devoting themselves to the spread of the simple truths they learned from the book of God, they traversed the entire region west out to the Mississippi river, accomplishing great good. Subsequently [385] Francis came into Kentucky, and Henry, bringing his slaves to Illinois, freed them there and distributed among them a large portion of his estate. Finally settling in this State, he continued his labors in the gospel with extraordinary success until the close of life, greatly endeared by his labors and sacrifices and noble Christian character to the entire community. He had remarkably correct views of the gospel, great faith in God and in Providence, praying always for everything, and urging the necessity of a new and of a divine life, of spiritual-mindedness, of entire devotion to God and

of the presence and aids of the Holy Spirit. In church discipline also he desired to see a strict enforcement of the Scripture precepts and a prompt separation of those who walked unworthily. Removing finally to Eureka, in Woodford county, he died in September, 1861. His brother Francis, emigrating to Missouri in 1836, has labored most successfully in that State, and still preaches as well as ever, though eighty years of age, having been for more than half a century engaged in the ministry.

Elder H. D. Palmer

Henry D. Palmer was a native of South Carolina, but early in life removed to Tennessee. He was a citizen of the latter State at the time of the Louisiana Purchase, and went as a volunteer to aid in the ceremony of unfurling the national flag at New Orleans.

As a Christian minister, he was an efficient worker with the early pioneers of the reformation headed by Barton W. Stone and Alexander Campbell.

In 1816 he removed to Illinois, locating near Vincennes, where he renounced all affiliation with American slavery by a formal emancipation of all his servants, believing the institution to be one of violence, unsupported by Christian principles.

About 1820 he removed to Indiana, and was a citizen of that State until 1835, when he removed to Illinois, locating in that portion of Putnam now included within the boundaries of Marshall county. In 1847 he represented his county in the convention called to revise the constitution of the State.

In 1849 he was nominated as one of the original trustees of Walnut Grove Academy, but declined to accept the appointment on account of his advanced age.

More than fifty years of his long life were zealously devoted to the work of the Christian ministry. At Cincinnati, Ohio, in 1849, he assisted in organizing the first General Christian Missionary Society. In 1850 he assisted in organizing the first Christian Missionary Society of Illinois, and was elected the first president of that body. Many young men through his influence were induced to enter the Christian ministry. About 1850 he became acquainted with O. A. Burgess, explained. to him the gospel of Christ as taught by the promoters of the Current Reformation, received his confession, baptized him, induced him to become a Christian preacher, and subsequently to enter Bethany College. He died during the first

In September 1788 this deponent [Fielding Woodruff] was in Salisbury and in Company with Henry Giles who informed me he owned a Race mare called Nancy Dawson which mare he the said Giles Consented I should take to So. Carolina to get a Race on. Some time after I had arrived at Camden with the Mare, John Blanton, who then lived in North Carolina, came to my house in Camden and Brought to that County with him a horse called Greenlee, which horse I understood was the property of Henry Giles. The said Blanton informed me Giles had promised to meet him in Camden about that time and in a few days after Blanton informed Giles had wrote to him he could not come down as he had appointed and for him the said Blanton to apply to me for the Mare Nancy Dawson which letter signed by Henry Giles he showed me tho I did not deliver him the Mare. When Blanton was about to Return to North Carolina, he mentioned to me he thought it best for the Interest of Mr. Giles to dispose of the Creatures as there was but little prospect of Run[n]ing them in the Country and he the said Blanton left the Horse Greenlee with Burwell Boykin of this neighbourhood. Some time after Blanton left me, I received a letter from him directed to me and Burwell Boykin informing us he had sold Nancy Dawson and Greenlee to Capt. Strother on Certain Conditions which was that he the said Strother was to procure him the said Blanton a Receipt from Major Winn for Three hundred and twenty five Guineas agreeableto a Debt he the sd Blanton owed to Winn in Instatment Bonds. He the said Strother came to me with a Receipt tho I don't know if it was agreeable to Contract or not he the said Strother left the Receipt with me for Blanton but I did not deliver him the mare but told Capt. Strother if Blanton would make good right to the Horse and Mare I would purchase one half of said nags of him and the price we agreed on some time afterward. I Recd a Letter from Henry Giles wherein he mentioned he had heard Blanton had sold his Creatures and desired me to tell Blanton if he had not firmly sold them not to do it and after some time I Received one other letter from Giles mentioning he was glad to hear I had got his Horse Greenlee in my possession as I had got him out of Mr. Boykins possession he the said Giles directed me to keep them in my hands and Deliver them to no One if Ithought there was anything to be done in the Raceing line to take his Mare Nancy Dawson with me to Charleston. Minor Winn and Jno Blanton came to me in Camden, said Winn Spoke to me on the Business in behalf of Capt. Strother and wished to know if Strother was to have the nags or not. I told Winn I had Recd Orders from Giles not to Deliver the Creatures to any person but to keep Possession of them as his property which Letter as my authority I shewed him the said Blanton and Winn and at the same time Returned the receipt that Strother had left with me, And did consider the Conditional Bargain between Blanton and Strother and Strother and myself to be Void; the mare Nancy Dawson I took to Charleston agreeable to Mr. Giles's instructions and left her in the hands of ****Henry Delony**** who I have heard sold her to a Mr. Alston near Georgetown in this State where I expect she now is. The Horse Greenlee was Legally attached and taken out of my possession as the property of Henry Giles for a Debt owing by him in Camden. The said horse Greenlee was in the hands of the Sheriff a considerable time, at length Giles came down, settled the deamnd and left the horse in my possession where he Remained untill he Died. I never did Deliver the Mare Nancy Dawson or the horse Greenlee to any persons in Consequince of any Bargain made by Blanton and Strother, nor did I ever Consider the property of the said Horse & Mare altered by the Conditional Bargain made by the said Blanton & Strother But always Considered them the property of the said Henry Giles.[signed] F. Woodruff

And Alexander Kincaid Securities of whom the Court approved, to be bound in the Sum of twenty pounds, the Administration presented by law.

Called "William" in Worth's /Tennessee Cousins/, citing surely incorrect VA service during the Revolution, but called "Francis" (or William Francis) in /Tennessee Records (1933) metioning his residence in Fairfield District, where Francis Rose Palmer was born in 1790.

William Palmer, from Virginia and South Carolina.

William [actually probably Francis] Palmer, the father-in-law of Charles Ready, was born in King William County, Virginia in 1752, and moved from there to Fairfield district, South Carolina. He is supposed to have served in the American Revolution. After the Revolution, he removed to Tennessee and settled near Lebanon, in Wilson County, but after his death, his widow moved to Rutherford County and lived with the Readys at Readyville.

William [properly Francis] Palmer and his wife Caroline Dulaney were the parents of children as follows:

- 1. Philip Palmer died young.
- 2. William Palmer, who was born in 1777 and died in 1857 in Lebanon, Tennessee. He married Susan Rankin, and they were the parents of 13 children.
- 3. Henry Dulaney Palmer, born, Charleston, South Carolina, preacher.
- 4. Susan Palmer.
- 5. Francis Rose Palmer, also a preacher at Independence, Missouri.

Death of Elder Francis R. Palmer. Died at his residence in this city on the morning of the 22nd, Elder Francis R. Palmer. He was born in Fairfield District, South Carolina, August 30, 1789. Removed with his father to Sumner County Tennessee, about the year 1795. Became a member of the church in 1809. Was in the War of 1812 under Jackson at Pensacola and New Orleans. Was a member of a spy company. Fired on the British on the 23rd December, 1814, below New Orleans. Was at the Battle of New Orleans and witnessed the entire charge of the British army. Was that his post of observation between the armies when the action began. Removed to Kentucky in 1816. Became a minister of the Gospel in 1812. Removed to Missouri in 1836, and to Clay County in 1865. In the death of Elder Palmer the county has lost one of his best citizens, the church of which he was so long the minister, one of its most faithful workers, and his family a kind and loving husband and father. Peace to the ashes of the venerable patriarch.

William Francis Palmer was born in King William Co. Va., about 1752. Died 1824, near Lebanon, Wilson Co., Tn. Corporal in Capt William Johnston's and later Everard Meador's Company; Col Daniel Morgan's Regiment, Virginia Troops, March 1, 1778. (From supplemental paper of Laura Lillian Jetton, 179060). It is said he served in the Revolutionary War under Gen. Francis Marion, some say under 'Light Horse' Harry Lee. He lived after marriage in North & South Carolina. Lived in Fairfield District, S.C., later.

He married Caroline Dulaney (French decent) of the eastern shore of Maryland.

After the war he moved with family to Tennessee; settled on Duck River. Caroline Dulany had a sister who married Charles Ready, whose son, Col. Charles Ready, married her daughter, Mary Palmer. (His first cousin) His daughter, Mary Ready, and family settled near Murfreesboro, Tenn., at the same time. Both sisters, after they were widows, lived with Charles & Mary Ready and are buried at Readyville, Tenn. This came from Mr. Van Armstrong.





Do you offer tours, genealogy information or ideas for us to enjoy Winnsboro that is relevant to our family history? I also know Dan Smith and Tom (Thomas) Roseboro had slave narratives. If you any additional information that would be awesome. I live in Texas and hope to visit soon.

A2: I am going to Cc this to Eddie Killian who is our genealogy research department director. We have very much on your family and several other descendants have been in touch with us over the years. George Roseborough visits occasionally, and I will also Cc him here. You can go to Eddie via this email to join the genealogy society and go onto the searchable site. Also, he will be able to help you remotely via email once you both establish contact. I believe that Tom Rosborough is buried in the Cemetery St. graveyard that is overgrown on the edge of a forested hillside, but probably approachable in winter once the undergrowth has lost leaves. George can correct me here if I am wrong but Eddie also has listings for many of the area cemeteries.

I: George Roseborough, the "Thomas Roseboro in the Cemetery Street cemetery is not related to me and my family. He took the name Roseboro and began using it because his former slave owner was very cruel to him during slavery, so he said that he did not want to be called by his name. The Thomas Roseboro in my family was William Thomas Roseboro. He and Reuben were sons of William and Kate Roseboro. My uncle Thomas, and his brother Andrew migrated north to Toledo, Ohio where they died.

Q: Jacqueline Kehinde, I am conducting genealogical research on the Ford family in Fairfield County, South Carolina. I am particularly interested in understanding the familial relationship between **Judy Ford**, the wife of **Sanders "Sandy" Ford**, and **Durete Ford**, who appears in the 1860 U.S. Federal Census with a daughter named Letitia Ford. 

owned and sold the same tract of land (474 acres) between themselves from 1872 to 1876, I believe. That parcel may have originally been included in acreage owned by the Wyrick family (willed by Nicholas to his son, Jacob, possibly). It was bounded by lands of James B. McCants and Col. D.D. Fenly. Unfortunately, none of these people's names are visible on the 1876 Fairfield County map that I can see. So, just let me know what direction to start looking!!

A1: Yes to McCants, Fenly, Wyrick, and Clowney. McCants should be on the 1876 map, as well as the 1820. See attached with Mrs. McCants on the edge of TWP 9 by the railroad and Highway 34. Wyrick was early and down on Little Cedar Creek. So was McCants on Little Cedar. However, map locations are not really relevant to your search here as farmers were constantly buying and selling lands. Here is a digitally searchable manuscript that we have here in the museum and loaned to the USC Digital project. It is searchable on families in the SW area of the county such as Wyrick, McCants, and possibly Fenly (Finley). These were early settlers. Clowney was all over the western to middle, and later into the town of Winnsboro later. Send this query directly to Eddie and see if he has a better idea of how to get started on this. Also, Eddie is constantly adding digitally searched family papers on the FC Genealogy site. He also is digitizing some of the old courthouse land records and can help on some of these.




1820 Robert Mills map of southeast part of Fairfield County

We do not have much for the Wise families in your inquiry. I have attached what we have in our collection that may be helpful to you a book called, "Reconstruction of the Genealogy of the Wise Family of the Congarees", by William Rudolph Bauer. Here is a quick link to the digitized information on our FCGS Members Only web pages for: <u>Alston, Allston</u> families.

I: Nathaniel Alston, My great-grandmother, Katie Alston Wise, passed away when I was 12 years old. I remember her, but I wish I could have recorded her voice. That is why I launched on my website, 'Lifelong legacy.' www.natalston.com The idea is to interview and record people over the age of seventy, let them tell their stories of their life experiences, and share them with their families and friends in the years after. My genealogy search has led me to Jenkinsville, SC. My late uncle said my great-grandmother was born in the Jenkinsville area, and when I visited the area, I discovered Alston, SC. Plus, I researched and found a book titled "The Alston's of North & South Carolina. I also found the listing of a William Alston, a slave owner in the area. My grandfather's first name was William Alston, and I assume that my great-grandmother Katie Alston Wise may have been born on his plantation. The name Wise was what she was called later in life.

Q: Sandra Parham Turner, you may have read the article I contributed to the latest CFM Family Association newsletter, which tells my family connections, but I am a descendant of Henry JR Coleman and Mary Mobley Coleman through their granddaughter, Mary Emily Coleman, whose stepfather was David Roe Feaster. I contacted the Fairfield County Historical Museum looking for information about the diaries of David Roe Feaster, and they gave me your contact information. I have a PDF copy of one from 1884-1889 that was typed up, I'm assuming several decades ago. I'm trying to find where the original might be and wondered if it was housed at the museum. In the article, I wrote about DRF's granddaughter, Edith Feaster May, who had saved a lot of history, and her daughter Sybil gave it to me. Sybil died last year, and now I have noone to explain to me where the information came from. For instance, either Edith or Sybil transcribed by hand another diary that DRF kept from 1905-1909, which I have transcribed on my computer. Then I found where one of them had written down a few entries from the 1884-89 diary that I assumed were in the typewritten copy, but they were not. So now I think that the typewritten copy may not be a complete transcription. I have no idea where they were when they copied either of these diaries or who might have had the originals when they did. Would you have any information I could go on to track down the 1884-89 diary? It may be lost to the ages, but if there's a possibility it exists somewhere, I would like to find out. I thank you for any help you can give me!

A: The Fairfield County Genealogy Library does have a PDF copy of this diary, but not the original. Ron Chicone checked at the Carolinian Library, and they do not have the original. Pelham Lyles said she only has a digital typed copy and does not know where the original is either.


Q: Ron Chicone, Jr., according to the article I sent earlier, Little Egypt is Buckhead, and the old house there was a part of Maj. T. Means' plantation. I think this conflicts with other accounts of Buckhead being on Buckhead Rd. But, the article says "Means' plantation was called Buckhead and was on Hemp Patch Fork and is marked on Mills 1820 map." That's Beaver Creek and Sandy Fork.
